

ARTICLES OF INCORPORATION OF JOHN GAMBER ENTERPRISES, INC.

The undersigned incorporator, for the purpose of forming a corporation in accordance with the Florida Business Corporation Act, hereby adopts the following Atticles of FLORIDA Incorporation.

ARTICLE I. NAME
