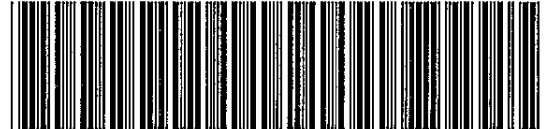

**ARTICLE I - NAME AND PRINCIPAL ADDRESS**

The name of the corporation is Murphy-Sunbelt Business Advisors, Inc., and the principal address and principal place of business is 513 North Belcher Road, Suite A, Clearwater, Florida 33765.

**ARTICLE II - REGISTERED OFFICE AND AGENT**
