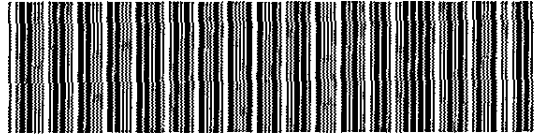

SECOND: Amendment adopted:


ARTICLE I. - NAME
