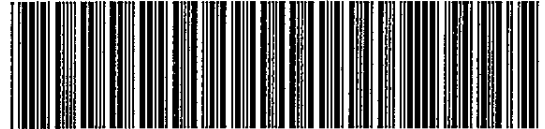

**ARTICLES OF INCORPORATION
OF IN HIS WORD PUBLISHERS, INC.**

ARTICLE I – NAME

The name of this for-profit Corporation shall be In His Word Publishers, Inc.

ARTICLE II – PRINCIPAL OFFICE


