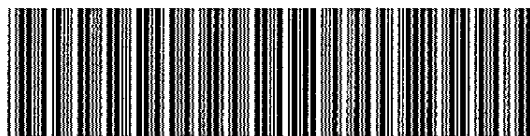

Articles of Incorporation

OF

RPD ENTERPRISES, INC.

The undersigned, Ronald M. Perry, whose address is: 897 N.W. 82nd Avenue, Coral Springs, Florida 33071, being at least eighteen years of age, does hereby form a corporation in compliance with Chapter 607 and/or Chapter 621, F.S. (Profit) and under the laws of the State of Florida.

ARTICLE I NAME

The name of the corporation is RPD Enterprises, Inc.

ARTICLE II PURPOSE

The purpose for which the corporation is organized is to operate a tennis/swimming club, tennis training facility, provide tennis lessons, provide management/promotion/consultation services to tennis players or tennis programs, and to perform any other business operations permissible under Florida law.
