

ARTICLES OF INCORPORATION

ARTICLE ONE

The name of this corporation is METAL SUPPLY INDUSTRIES, INC. and the mailing address of the corporation shall be 6340 Arc Way, Fort Myers, FL 33912.

ARTICLE TWO
