I, ALLAIN BELIZAIRE the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I

The name of this corporation shall be, KYSKEYA RESTAURANT, INC.
Initial address shall be 6020 N. FEDERAL HIGHWAY, BOCA RATON,

ARTICLE II
