IN WITNESS WHEREOF, this Amendment to the Articles of Incorporation was executed by all shareholders of the Corporation on April 10, 2006.

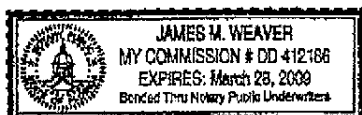
