#### ARTICLES OF INCORPORATION OF MASOOD H. KHAN, M.D., P.A.

05 MAY -6 PM 2: 32

The undersigned natural person, competent and licensed to practice medicine in the State of Florida, acting hereby as Incorporator for the purpose of forming a Professional Service Corporation for profit under the provisions of Section 607, Florida Business Corporation Act, and Section 621, Florida Professional Service Corporation Act, of the Florida Statutes, does hereby adopt the following Articles of Incorporation:

#### ARTICLE I

#### NAME OF CORPORATION, PRINCIPAL OFFICE AND MAILING ADDRESS

The name of this corporation shall be: MASOOD H. KHAN, M.D., P.A.

The principal office of this corporation shall be: 37241 Medical Drive, Dade City, FL 33525.

The mailing address of this corporation shall be: P.O. Box 915, Dade City, FL 33526-0915.

#### **ARTICLE II**

#### **PURPOSE**

The general nature and purposes of business to be transacted, promoted and carried on by the corporation are as follows:

- a. To engage in every aspect in the practice of medicine and all its fields of specializations, as are engaged in by physicians.
  - b. To engage and render the professional services involved only through its officers,

- a. The maximum number of shares of stock that the corporation is authorized to have outstanding at any time shall be one thousand (1,000) shares of common stock.
- b. Shares of the corporation's stock and certificates shall be issued only to physicians in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional services as this corporation.

#### ARTICLE IV

#### DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles with the Department of State.

#### ARTICLE V

#### INITIAL REGISTERED OFFICE AND AGENT
