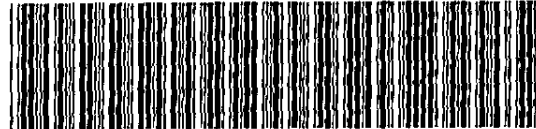

ARTICLES OF INCORPORATION

The undersigned incorporator hereby forms a corporation under chapter 607 of the laws of the State of Florida. SECRET STATE TALLAHASSEE, FLORIDA

ARTICLE 1- NAME

The name of this corporation is KOGER HOME REPAIRS, INC.

ARTICLE 2- PRINCIPAL OFFICE

The street address of the initial principal office of the corporation shall be: 4700 Long Key Lane, Coconut Creek, Fl 33073.

ARTICLE 3- PURPOSE

The corporation is organized for the purpose of home repair or in any activity permitted by this State or the United States.

ARTICLE 4- CAPITAL STOCK
