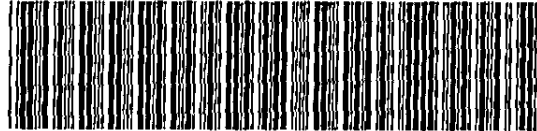



The initial officer shall be as President, Nelson Oramas.


