The undersigned incorporator hereby executes and acknowledges these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

ARTICLE I Name

ARTICLE II Principal Office and Mailing Address

ARTICLE III Business and Purposes

The general purpose for which this corporation is organized is the transaction of any and all lawful business for which corporations may be incorporated under the Business Corporation Act of the State of Florida, and any amendments thereto, and in connection therewith, this corporation shall have and may exercise any and all powers conferred from time to time by law upon corporations formed under such Act.

ARTICLE IV Capital Stock

(a) The aggregate number of shares of capital stock authorized to be issued by this corporation shall be **Ten Thousand (10,000)** shares of common stock with a par value of **One Dollar (\$1.00)** per share. (b) In the election of directors of this corporation, there shall be no cumulative voting of the stock entitled to vote at such election.

ARTICLE V Existence of Corporation

In accordance with Section 607.0203, Florida Statutes, the existence of this corporation shall commence upon the filing of these Articles by the Department of State. The existence of this corporation thereafter shall be perpetual.

ARTICLE VI Registered Office and Registered Agent

The initial registered office of this corporation shall be located at **109 S. Moody Avenue**, **Tampa, Florida 33609** and the initial registered agent of this corporation at such office shall be **DARIO D. DIAZ**. This corporation shall have the right to change such registered office and such registered agent from time to time, as provided by law.
