

The undersigned subscriber to these Articles of Incorporation hereby forms a Corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be: Peace Maker-web.com, Inc. The principal place of business will be 5313 11th Avneue South, Gulfport, FL 33707.

ARTICLE II - DURATION

This corporation shall have perpetual existence.
