I, the undersigned, hereby form this corporation under the laws of the State of Fiorida, providing for the formation, rights, privileges, immunities and liabilities of a corporation for profit.

#### ARTICLE I

The name of the corporation shall be:

The foregoing right of indemnification shall be in addition to and not exclusive of all other rights to which such director, officer, or employee may be entitled.
