

**ARTICLES OF INCORPORATION
OF

THE UNDERSIGNED, acting as sole incorporator of KDA AUTO & TRACTOR RECOVERY, INC., INC. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

Name


