ARTICLES OF AMENDMENT to ARTICLES OF INCORPORATION of BRADDOCK REALTY, INC. A Florida Corporation



Pursuant to the provisions of section 607.1006, Florida Statutes, the Florida profit corporation adopts the following amendment to its Articles of Incorporation.

1. Article 5 of the Articles of Incorporation of Braddock Realty, Inc. (the "Corporation") is amended as follows:

ARTICLE 5 PRINCIPAL OFFICE AND REGISTERED AGENT
