ARTICLE I - NAME AND PRINCIPAL ADDRESS**

The name of the corporation is ALL ABOUT LAWNS & LANDSCAPING, INC., and the principal address and principal place of business is 10075 88<sup>TH</sup> STREET NORTH, SEMINOLE, FLORIDA 33777.

**ARTICLE II - REGISTERED OFFICE AND AGENT**
