We the undersigned, in order to form a corporation for profit for the purposes hereinafted stated, under and pursuant to the provisions of the Florida Statutes, do hereby subscribe to this Certificate of Incorporation, and to adopt the following Articles of Incorporation:

ARTICLES OF INCORPORATION

<u>ARTICLE I –NAME</u>

The name of this Corporation shall be: CAPIRO TOWING CORPORATION

ARTICLE II -PURPOSE OF CORPORATION

The general nature of the business and the objects and purposes to be transacted and carried on by this corporation shall be:
