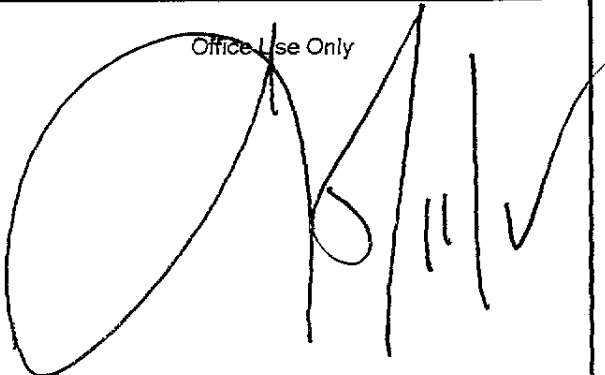

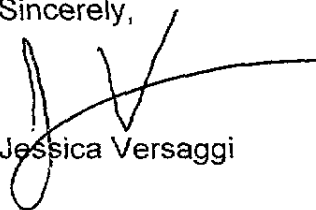

ARTICLES OF INCORPORATION

Wishard Crane, Inc.

The undersigned, acting hereby as Incorporator for the purpose of becoming a corporation under the laws of the State of Florida, providing for the formation, liabilities, rights, privileges and immunities of a corporation for profit, pursuant to Chapter 607, Florida Statutes, and other applicable law, do hereby adopt the following Articles of Incorporation:

ARTICLE I

Wishard Crane, Inc.

The name of this corporation shall be, **Wishard Crane, Inc.**, 4125 State Road 16, St. Augustine, Florida 32092, (904) 940-1695.

ARTICLE II

DURATION

This corporation shall have a perpetual existence unless sooner dissolved according to law. Upon dissolution of the corporation all assets of the corporation, including real property and bank accounts, shall be given to: **Wishard Crane, Inc.**, 4125 State Road 16, St. Augustine, Florida 32092 (904) 940-1695. ARTICLE III

PURPOSE

The purpose of this corporation is to conduct the business of off site, commercial crane operation at various work sites for various work orders under the Florida General Corporation Act.

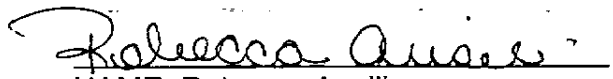
