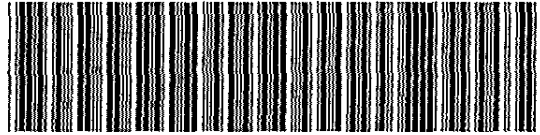

**ARTICLES OF INCORPORATION
AIRPORT TRADE CENTER ASSOCIATION, INC.**

ARTICLE I

The name of this corporation is AIRPORT TRADE CENTER ASSOCIATION, INC. Whose principal address is 7201 N.W. 46th Street Miami, Florida 33166.

ARTICLE II

The general nature of the business to be transacted by this corporation is to engage in Auto collecting & paying for common area maintenance, a business permitted under the laws of the State of Florida.
