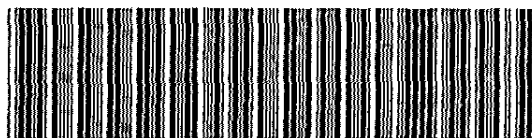

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME AND ADDRESS

The name of the corporation is DBS OF SW FLORIDA, INC. The principal business address of the corporation is 4802 6th Street W Lehigh Acres, Florida 33971.

ARTICLE II. NATURE OF BUSINESS

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE III. CAPITAL STRUCTURE

The maximum number of shares of stock that this corporation is authorized to have outstanding at any on time is One Thousand (1,000) shares of common stock of the same class each having a par value of One Dollar (\$1.00).
