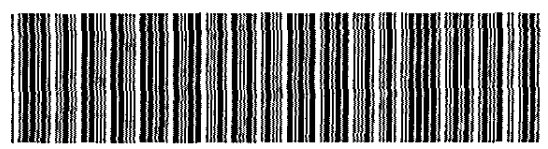



**ARTICLES OF INCORPORATION
OF
PALMER MAINTENANCE SERVICE, CORP.**

Article I. Corporate Name

The name of this corporation is PALMER MAINTENANCE SERVICE, CORP., and its principal place of business is to be located at, 20321 N.E. 10th Court, North Miami Beach, FL 33179.

Article II. Nature of Business and Powers

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.

Article III. Capital Structure

A. The Board of Directors can create any type of Capital Structure necessary for the operation of the corporation. There can be different stocks of Par Value and Non-Par Value.

B. The initial capital structure of PALMER MAINTENANCE SERVICE, CORP., is \$1.00 par value. The maximum number of shares of stock that this corporation is authorized to issue and have outstanding at any one time is 100 shares of common stock having \$1.00 per par value.

Article IV. Term of Existence

This corporation shall have perpetual existence, commencing upon filing of these articles.

Article V. Registered Agent and Initial Registered Office
