**ARTICLES OF INCORPORATION  
OF  
EXPERTISE PROFESSIONAL CLEANING SERVICE INC**

**ARTICLE I - NAME**

The name of the corporation is EXPERTISE PROFESSIONAL CLEANING SERVICE INC.

**ARTICLE II - ADDRESS**

The initial principal office of the corporation is 15 Herring St, Melbourne, FL 32901. The initial mailing address is the same. The Board of Directors may, from time to time, move the principal office and/or mailing address to any other address.

**ARTICLE III - DURATION**

The term of existence of this corporation shall be perpetual.

**ARTICLE IV - PURPOSE**

The purpose of the corporation is to transact any and all business lawful under the laws of the State of Florida.

**ARTICLE V - CAPITAL STOCK**

The aggregate number of shares of stock, which the corporation has authority to issue, is 100, all of which shall be common shares with a par value of \$1.00 each.

**ARTICLE VI - SECTION 1244 STOCK**

It is the intention of the Incorporators that the stock of this corporation shall qualify as Small Business Company Stock pursuant to Section 1244 of the Internal Revenue Code.

**ARTICLE VII - PREEMPTIVE RIGHTS**

Each shareholder, upon the sale of any new stock of this corporation, shall be entitled to the full pre-emptive rights to purchase his pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.
