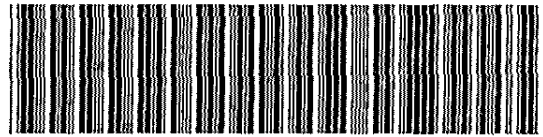

### INDEMNIFICATION



### AMENDMENT






