#### **ARTICLES OF INCORPORATION OF**

#### SAGAWA CAPITAL, INC.

I, HAJIME SAGAWA, the undersigned incorporator of this corporation under Sections 607.194, Florida Statutes, as amended, do hereby form this corporation and adopt following Articles of Incorporation.

## ARTICLE I


