# ARTICLES OF INCORPORATION OF KAGEDY,, INC.

The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

#### ARTICLE I

The name of the corporation is KAGEDY, INC.

#### ARTICLE II

The corporation is to commence its corporate existence on the date of subscription and acknowledgement of these Articles of Incorporation and shall exist perpetually thereafter unit dissolved according to law.
