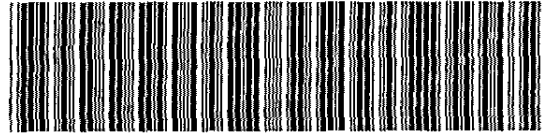

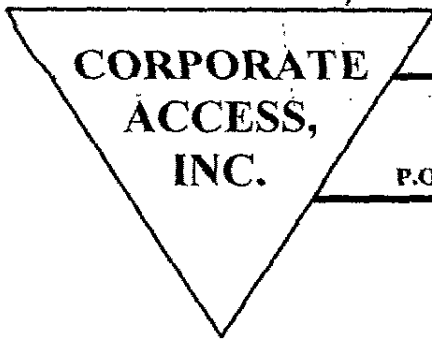

**ARTICLES OF INCORPORATION
OF
DORA F. SMITH, P.A.**

The undersigned incorporator to these Articles of Incorporation, being duly licensed to engage in real estate sales under the laws of the State of Florida, adopts these Articles to form a corporation under the Professional Service Corporation Act, F.S. Chapter 621, and other laws of the State of Florida.

ARTICLE I - NAME

The name of the professional service corporation is DORA F. SMITH, P.A.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be 1251 Shorecrest Circle, Clermont, FL 34711

ARTICLE III - PURPOSE

The professional service corporation is formed to engage in every phase and aspect of the real estate sales. 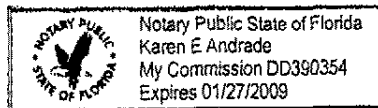
