



ARTICLES OF INCORPORATION OF DORA F. SMITH, P.A.

The undersigned incorporator to these Articles of Incorporation, being duly licensed to engage in real estate sales under the laws of the State of Florida, adopts these Articles to form a corporation under the Professional Service Corporation Act, F.S. Chapter 621, and other laws of the State of Florida.

ARTICLE I - NAME

The name of the professional service corporation is DORA F. SMITH, P.A.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be 1251. Shorecrest Circle, Clermont, FL 34711

ARTICLE III - PURPOSE

The professional service corporation is formed to engage in every phase and aspect of the real estate sales.
