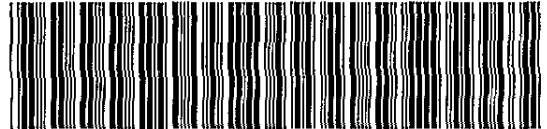

PREEMPTIVE RIGHTS:
