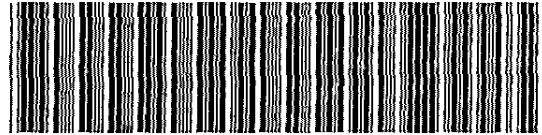



ARTICLES OF INCORPORATION OF

Lollipop Party Rental, Inc.

The undersigned, for the purpose of forming a corporation under the laws of the State of Florida, do hereby adopt the following articles of incorporation:

ARTICLE I - NAME AND PRINCIPAL OFFICE

ARTICLE IV - INITIAL OFFICERS AND DIRECTORS


The initial Board of Directors shall have one (1) member whose name and address are as follows:
