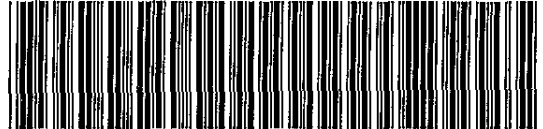

The Articles of Incorporation of Chirayu Inc. are as follows:

**Article I. NAME**

The name of the corporation is CHIRAYU Inc. "The Corporation".

**Article II. PRINCIPAL OFFICE**

**Article III. PURPOSE**
