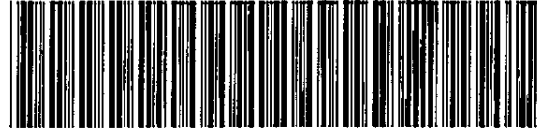

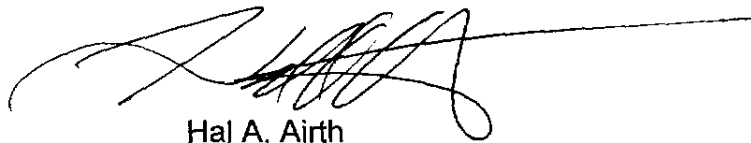

ARTICLES OF INCORPORATION
OF
LARRY MARTIN INSURANCE, INC.

ARTICLE I

The name of this corporation is **LARRY MARTIN INSURANCE, INC.**

ARTICLE II

The corporation is to exist perpetually, commencing on the date of filing and recording of these Articles.

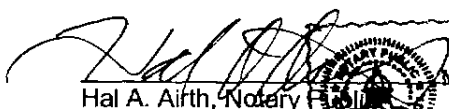
