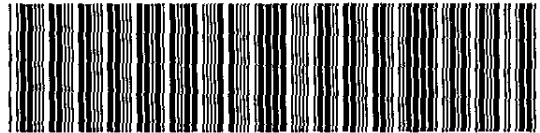

ARTICLE I
(name)
