ARTICLES OF INCORPORATION OF

The undersigned Incorporator (s), for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt (s) the following Articles of Incorporation.

ARTICLE I - NAME

The corporation shall exist perpetually. Corporate existence shall commence upon filing to the Department of State

ARTICLE III - NATURE OF BUSINESS
