## AMENDED AND RESTATED ARTICLES OF INCORPORATION

These Amended and Restated Articles of Incorporation of Cherokee Media FX, Inc. shall replace the Electronic Articles of Incorporation filed with the Secretary of the State of Florida on May 13, 2005. These Amended and Restated Articles of Incorporation we approved and adopted on January 23, 2007 by the board of directors of the Corporation and no shareholder action was required.

# ARTICLE I - NAME

The name of this Corporation is CHEROKEE MEDIA FX, INC., a Florida corporation.

### ARTICLE II - ADDRESS

## ARTICLE III - GENERAL NATURE OF BUSINESS
