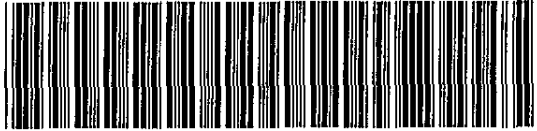

Bylaws




