

**ARTICLES OF INCORPORATION
OF
Preston Fire Protection Design, Inc.**

The undersigned, for the purpose of forming a corporation under the laws of the State of Florida do hereby adopt the following articles of incorporation:

ARTICLE I

The name of the corporation is **Preston Fire Protection Design, Inc.**

ARTICLE II

The duration of the corporation is perpetual.

All holders of shares of common stock, upon the dissolution of the Corporation, shall be entitled to receive the net assets of the Corporation.


