ARTICLES OF INCORPORATION

The undersigned subscriber, a natural person competent to contract for the purpose of forming a corporation under the laws of the State of Florida, adopts the following Articles of Incorporation for such corporation.

ARTICLE I

The name of this corporation shall be, Finish First Cabinetry, Inc..

Its principal office shall be at 5283 SE 43rd Trace, Okeechobee, Florida 34974 or at such other place as may be designated, from time to time, by the Board of Directors.

ARTICLE II
