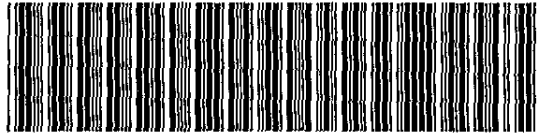



OF



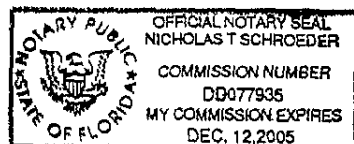


