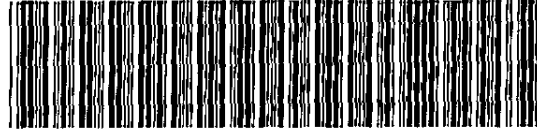

**ARTICLES OF INCORPORATION  
OF  
B.I.G. FIRE PROTECTION, INC.**

In compliance with the requirements of F.S. Chapter 607, the undersigned hereby act as incorporators in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the Corporation is: B.I.G. Fire Protection, Inc..

**ARTICLE II**

The street address of the principal office of the Corporation is: 16106 Pine Ridge, Hudson, Florida 34667.

**ARTICLE III**

The maximum number of shares this Corporation is authorized to issue is 300, par value \$1.00 per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.




