

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation is COASTAL POWER, INC.

ARTICLE II - PRINCIPAL OFFICE

The principal office of this corporation is located at 3450 Metro Parkway, Unit 8, Fort Myers, Florida 33916.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business permitted under the laws of Florida.


