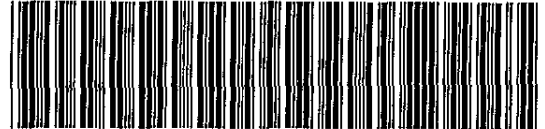

Executed by the undersigned for the purpose of forming a for profit corporation in compliance with Chapter 607 and/or Chapter 621, F. S. (Profit):

ARTICLE I

The name of this corporation is **Fred J. Sandlin Marketing, Inc.** The principal place of business and mailing address of the Corporation is **1635 South Ridgewood Ave Suite 206 S Daytona, FL 32119.**

ARTICLE II

The duration of the Corporation shall be perpetual.

ARTICLE III
