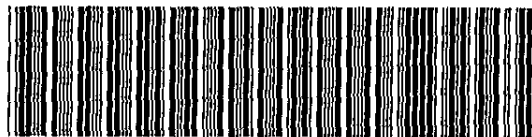

The undersigned incorporator for the purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

- FIRST: The name of the Corporation is **MARC A. DIAZ, P.A.**
- SECOND: The principal office address and mailing address of the Corporation is 3475 N Country Club Drive, #202, Aventura, FL 33180.
- THIRD: The Corporation is authorized to issue 7,500 shares of common stock, par value \$1.00 per share.
