# Article 1 - Name

The name of this corporation is IDS PROPERTIES, INC.

# **Article 2 - Duration**

This corporation shall exist perpetually.

#### Article 3 - Purpose

This corporation is organized to do any and all business permitted under the laws of the State of Florida.

# Article 4 - Capital Stock

This corporation is authorized to issue One Hundred (100) shares of One (\$1.00) Dollar par value common stock.
