THE UNDERSIGNED, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I
NAME

The name of this corporation is CAPSTONE CONSTRUCTORS, INC. The principal place of business is: 24 West Chase Street, Pensacola, Florida 32502.

ARTICLE II
DURATION

The duration of this corporation is perpetual.

ARTICLE III
PURPOSE
