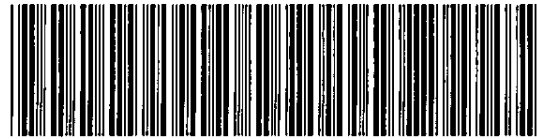

Amendment adopted:

Article I of the Articles of Incorporation of Florida State Corporation is amended as follows:
