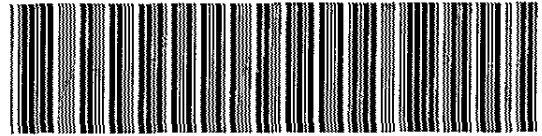

amended to read:



