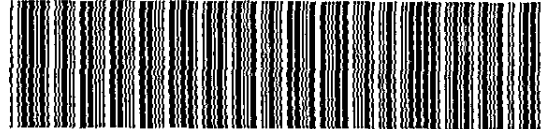

The undersign, acting as the incorporator of this corporation, hereby adopts the following Articles of the Incorporation as registered with the State of Florida

ARTICLE I: NAME

The name of the corporation shall be: DANVERS & BECKFORD TRUCKING INC., hereinafter referred to as the "Corporation".

ARTICLE II: PRINCIPLE OFFICE AND MAILING ADDRESS

ARTICLE VIII: AMENDMENTS

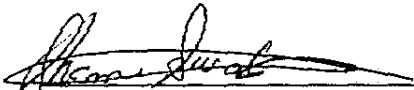
