

# **ARTICLES OF INCORPORATION**

# **BARRY JAMES PROPERTIES, INC.**

The undersigned, a natural person competent to contract, acting as incorporator of this corporation pursuant to Chapter 607, Florida Statutes, adopts the following Articles of Incorporation.

## ARTICLE I

## NAME

The name of the corporation is **Barry James Properties**, **Inc.** (hereinafter called the "Corporation").

### **ARTICLE II**

## PRINCIPAL OFFICE

The principal place of business and mailing address of this Corporation is 33 N.E. 8<sup>th</sup> Place, Cape Coral, Florida 33909.
