### ARTICLE III - NATURE OF BUSINESS

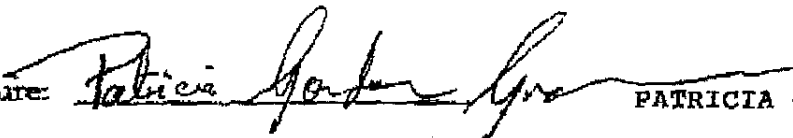
The corporation may engage in any activity or business permitted under the law of the United States and under the laws of the State of Florida
